# 9.c. People Wishing to Address the Board

#### Comments:

The following people addressed the Board:

- 1) Student 6th grader at Vallemar School, and son of a 1st grade teacher, expressed his concern in regards to family health benefits, and shared his personal medical issues that he and his parents have had to address. He asked that teachers be given the benefits they deserve.
- 2) Jonathan Harris Co-chair of the LSEA Bargaining Committee, and as a representative of LSEA, welcomed the new Trustees. He expressed he feels somewhat hopeful about the current negotiations and that things have seemed to turn back to somewhat resemble the Interest-Based Bargaining process that has been used in the past. LSEA is still disappointed that the District declared impasse and would ask that the Board take action to end the impasse process. He also shared they do believe that the District would like to provide the teachers with higher salaries and full benefits, and understand this is not possible.
- 3) Charlotte Jacobs teacher at Cabrillo School, welcomed the new Board members, and shared the teachers are looking forward to working towards a resolution and restoration of positive feelings throughout the district.

Ms. Gould shared that the Board has to remain in compliance with the Brown Act and are not allowed to respond to issues raised by those addressing the Board in Open Communications. However, she did want to acknowledge that the Board hears what is being said, and the Board appreciates those who come to the meetings to share their feelings about negotiations. The other Board members thanked those in attendance for the warm welcome, and also assured those addressing the Board that they are being heard.

She wanted to commend Facilities, Maintenance and Operations, District Office Staff, and site custodians for the outstanding job they did in caring for our facilities, supporting our families and staff, and making certain all issues were addressed before the open of school the next day. She also shared all schools and the District Office were able to close for two full weeks during the winter break, and Dr. Tukloff thanked LSEA and CSEA for working to make this happen for their members. Ms. Peterson introduced Sheldon Chavan of Chavan & Associates, LLP in attendance to provide the Board with the Audit Report. Mr. Chavan provided the highest of praises to Ms. Peterson and her staff,

and the staff at the sites. He indicated there were no findings in the 2013-2014 audit report, and that there were no internal control recommendations in the 2013-2014 audit report.

Additionally, Ms. Van Raaphorst indicated we are required to report on Adequate Yearly Progresss (AYP), which in the past was gathered via the STAR tests, which are no longer being used. That box now appears as a blank box. That will be changed to reflect n/a.

Dr. Tukloff indicated the County Committee is undergoing a process to redraw the trustee areas for the San Mateo County Board of Education. This review occurs approximately every ten years in order to evaluate the balance of represented populations. The boundaries are reviewed for elementary districts. Education Code stipulates to get as equal in represented populations as achievable. Pacifica School District could be affected by the County Committee's vote. The Board directed Dr. Tukloff to draft a resolution indicating Pacifica School District would be in favor of either the Status Quo or Plan 2 options allowing the District to remain with our fellow Jefferson Union High School partner districts.
