Maria Gavidia presented to the Board of Trustees Resolution No. 2019-03-27-I: Endorsing April as Global Autism Awareness Month.

Ms. Gavidia shared that April is Global Autism Awareness Month. Autism refers to a broad range of conditions characterized by challenges with social skills, behaviors, speech, language, and nonverbal communication. She noted that she is pleased that Autism awareness is now recognized globally.

Ms. Gavidia noted in her Board memo attached to this agenda item some of the ways that we can support those who live with Autism Spectrum Disorder (ASD). Those ways include: wearing blue during the month of April; watching for landmarks lit up in blue and point them out to family members, friends and neighbors; modeling acceptance and tolerance for diverse individuals; going to websites for organizations such as Autism Speaks and the Autism Society to learn more about ASD; and sharing what you learn with family and friends.

Ms. Gavidia shared that she has come to know our special educators since she began in July and shared with the Trustees that they should be proud of the work they are doing with our students.
