Meghann Elsbernd, LSEA Representative, addressed the Board and shared that LSEA is done for the year and is ready for negotiations next year. She thanked the bargaining team for their many hours of work on the agreement. Ms. Elsbernd introduced Christy Novack, the District's Access, Equity and Innovation Specialist.

Ms. Novack addressed the Board on behalf of Pacifica Education Foundation (PEF). She helps assist with messaging to the community on behalf of PEF and wanted to clarify the support PEF provides for the District, those supports include: 3rd,4th, and 5th grade music program and music teacher; aspects of the middle school program; a full year of SPARC Poetry; and professional development opportunities. For next school year, PEF has agreed to support the addition of Science Leads(Leads are defined as classroom teachers who are paid a stipend to support their particular sites in a particular area. Ms. Novack further clarified that at the last Board meeting the information regarding PEF roles was miscommunicated and she addressed the Board this evening to clarify those roles.

- The minimum reserve level required each year

- Reasons for the reserve being greater than the minimum

This requirement is in place for the adopted budget and the multiyear projections submitted with it.

Maria Gavidia presented the Memorandum of Understanding (MOU): San Mateo County Teacher Induction Services 2019-2020 to the Board of Trustees. In previous years this was called BTSA.

To fulfill the requirements for the California Clear Multiple Subjects and Single Subject Credential, newly credentialed teachers must complete a California Commission on Teacher Credentialing (CCTC) approved professional teacher induction program. This is a successful state-funded and Commission approved induction program that has proven to increase teacher retention due to the strong structure of reflecting on one's practice with a support provider (coach) over a two-year period. Pacifica School District offers induction to beginning teachers needing to fulfill the credentialing requirement.

The attached Board memo shows a 5-year breakdown and cost of this program.

With the passage of Proposition 30, the state created an Education Protection Account (EPA) to receive and disburse the revenues generated from Proposition 30. The Director of Finance estimates the total amount of funds by June 30th each year and the State Controller transfers the funds before the end of the fiscal year.

School Districts are required to estimate the EPA revenue and make a determination of how those funds are spent. The EPA funds do not increase the district's revenues; it is a shift of funds that the district was already receiving as state aid. As a requirement for receiving these funds, the Board must make the spending determination during an open Board meeting.

Attached is the Board Resolution along with copies of the CDE Certified EPA funds for 2018-2019 and the estimated EPA funds for 2019-2020.
