10.a. LSEA (Laguna Salada Education Association)

Minutes:

Meghann Elsbernd, LSEA Representative, addressed the Board. She shared that her word for this evening is Communication. She reported that LSEA has not received a response from the Board of Trustees to have informal meetings between LSEA and the Trustees.

Ms. Elsbernd shared that the communication between the Board and the community at large and between the District Office and the teachers needs to change. She reported that it took 8 days to communicate the new administrator position to employees. She asked for better communication by the Trustees and by the District Office.

10.b. CSEA (Classified School Employees Association)

Minutes:

Jerry Newland, CSEA Representative, addressed the Board of Trustees. Ms. Newland reported out about Classified positions that have not been filled. She shared that when asked about these unfilled positions, that there is no money. She questioned where the money came from for the new administrator, if there is no money. She mentioned the cuts in the past regarding Classified staff hours from 6 hours to 5.5 hours, and never regaining that half hour back.

Ms. Newland reported that other local stores and restaurants pay more than Pacifica School District. She asked the Board of Trustees for help. She stated that we cannot get employees at the rate of pay the District is offering.

10.c. People Wishing to Address the Board

Minutes:

President Villalobos called the following people who filled out a speaker card to address the Board of Trustees:

Ila Dwyer: Ms. Dwyer addressed the Board to report her frustration regarding appointing an administrator but not being able to find special education teachers to fill the open positions.

Jennifer Mitchell: Ms. Mitchell addressed the Board regarding the District's transparency with regard to monies being spent on an administrator and not reimbursement for curriculum.

Natalie Abinante: Ms. Abinante addressed the Board regarding support for the teachers and paraprofessionals in the classroom.

Jonathan Harris: Mr. Harris addressed the Board regarding the leadership role that the teachers take on day to day. He shared that Pacifica teachers are the lowest paid in the County and that hiring another administrator is disrespecting the teachers. He shared that raising the salary 5-6% for teachers will draw teachers to the Pacifica School District. He asked that the District consult with labor partners.

Joan Weideman: Ms. Weideman addressed the Board. She shared that she has been a volunteer, a former Board Trustee, and now a teacher in the District. She shared that when the District is facing difficult times that everyone come together and problem solve it together, including teachers.

Rachel Merlo: Ms. Merlo addressed the Board stating that LSEA proposed negotiation dates back in June and the District proposed a date in November. She shared that the District states that retaining teachers is a priority, but cutting school site funds and hiring an administrator does not support that priority, paying teachers more will attract and retain.

Darcy Fields: Ms. Fields addressed the Board to state that the District said in the past that there is no money for higher step increases, however, when the District needs something, there is always money available.

10.d. Correspondence

Heather Olsen shared correspondence received since the last Board meeting. She reported that she received correspondence from E-Rate Funding Category 2 that the District is receiving \$240,000 which will be used for routers and switches.

She shared that the North County Water District is celebrating their 75th anniversary; also the California Department of Education has reviewed the Special Education Annual Performance Report and the District passed; and the Ohlone Portola Heritage Day is on Saturday, November 2.

11.e. Local Control Accountability Plan (LCAP)(LCAP Goals: #1, #2, #3, Governance)

Minutes:

Will Lucey presented the Local Control Accountability Plan (LCAP) to the Board of Trustees. The LCAP Update presentation informed the Trustees regarding the district-wide 2018-19 LCAP outcomes and metrics. It includes looking at up-to-date CAASPP; ELPAC; Attendance; Discipline; Student, Staff and Family Perception survey data. A Pacifica School District Board of Trustees Work Study will be held on Wednesday, October 16, 2019 to take a closer look at both district-wide and site-specific data around the 2018-2019 Metrics and Outcomes.

The presentation is attached to this agenda item. Mr. Lucey reviewed each slide with the Board of Trustees.

Board discussion included questions and clarifications around each of the goals and how the District will improve meeting each goal. Discussion about getting a more accurate picture on R-FEP's (Reclassified Fluent English Proficient) with regard to ELA in Goal 2. Concerns from the Board relating to progress in some of the student groups of the data. Now that the District has this data what are we doing with this data in order to push it forward?

Joan Weideman, community member and math teacher at Ingrid B. Lacy addressed the Board to share that it would be beneficial for all teachers to have professional development for English Language learners, not only English Language Arts (ELA) teachers, as it is a challenge for all teachers to support English Learners.

11.f. Constitution Day (LCAP Goal: #2, Governance)

Minutes:

Will Lucey presented Constitution Day and shared the activities that the school sites participated in for Constitution Day.

Constitution Day is an American federal observance that recognizes the ratification of the United States Constitution and those who have become U.S. citizens. It is observed on September 17th, the day the U.S. Constitutional Convention signed the Constitution in 1787.

School-wide/classroom discussions and activities included: Integrated the observance with Family Day by integrating the entire school within a United States flag; Listened to the

School Rock Preamble over morning announcements; student developed and led announcements-Trivia for the day was about the Constitution; Interesting facts about the Constitution to share during the Morning News program; Opportunities for classroom lessons: Writing activities focused on key concepts such as freedom, the symbolic nature of the flag; Viewed Brain-pop video on US symbols and the Constitution (primary grades); Made Pledge of Allegiance Book; Watched CNN news segment on the Constitution and took a quiz(intermediate grades); Created a Classroom Constitution (middle school grades) applying the democratic process of voting to decide which to display.

11.g. Public Report on Developer Fees (Operations)

Minutes:

Josie Peterson presented Public Report on Developer Fees. She reported that this is a Public Hearing item which was noticed to the community and is an annual agenda item.

Ms. Peterson informed the Board of Trustees that developer fees are earned by the District when there is housing or new renovation development. The Board has very restrictive guidelines as to how those fees can be spent. The monies are spent when there is area of growth in enrollment. The District has not had enrollment growth in the last several years.

Board Comments: If we continue to have declining enrollment, we will continue to have this accumulating money that we can't spend? Ms. Peterson responded that the District would need to get legal advice on how we can spend this money. She shared that now is a good time to see how we can strategically spend this money as it has grown over the years. Are developer fees only from new projects and will our new housing project be subject to developer fees? Ms. Peterson shared that she is uncertain whether the District would fall in to the category to pay developer fees but that she would look in to it. She also explained that the fees come from remodeling not just new developments. Ms. Peterson stated that whenever a permit is generated through the city, it becomes a project subject to developer fees.
