Minutes:

Heather Olsen reported that she has heard often from teachers and parents around the special education teacher shortage. She shared that the District is currently short 3.25 special education teachers, which relates to 90 students currently not receiving services. Dr. Olsen shared that this the District's highest priority right now.

Dr. Olsen recommended that the Board of Trustees approve a job description for Coordinator of Human Resources and appoint Alexis O'Flaherty as Interim Coordinator of Human Resources.

The Board clarified that this appointment is an interim appointment. Dr. Olsen clarified that the position would be interim through the end of the school year. Dr. Olsen also mentioned that the District has an important immediate need and that the District has 10 unfilled Classified positions. She stated that the District needs to quickly rather than waiting for the next Board meeting.

The Trustees shared that the District not serving 90 kids is unacceptable, and that it's imperative that the District jump on this; a public comment was made recently that the District is taking away money from the classroom, however, this position will now be putting money back in to the classroom if we are servicing the District children; this is something that the District should have been working toward all along, but it has become more difficult to hire and retain, so the District needed to up the efforts; it seems like the logical solution; since this is an interim position, the District should have discussion about whether this should be a permanent position, if it's determined effective; the District is in a long term fight against all other peninsula districts who are in the same situation in getting staffing needs fulfilled.

Dr. Olsen shared that weekly updates to the Board around staffing and progress will continue.

- Individuals may address topics <u>not</u> on the agenda during the Communications Section (People Wishing to Address the Board) at the beginning of the meeting. However, the Board <u>cannot</u> comment on items not on the agenda.
- The Board, at their discretion, may limit the total time allotted for public comment during each agenda item.
- Individuals must be recognized by the Board President and step to the podium to speak.
- Speakers should introduce themselves and speak into the microphone. (The microphone is for the television and does not amplify sound.)
- Speakers are limited to a maximum of 3 minutes, which may be reduced at the discretion of the Board.
- Time allotments may NOT be passed from one person to another.
- An individual may speak only once on each agenda item.
