6.a. Public Hearing BP/AR 5141.52 Suicide Prevention (First Reading) - 7:45 PM

Time Certain: 7:45 PM

Minutes:

Ray Avila shared information regarding BP/AR 5141.52, Suicide Prevention. In the audience, Dr. Avila introduced Meghan Neuberger, Ingrid B. Lacy School Counselor, and Kristina Ireson, Mental Health Counselor for Pacifica School District. Laura Reinacher, School Counselor was also mentioned but was not able to attend the Board meeting due to illness.

San Mateo County Counsel, in collaboration with the San Mateo County Office of Education addressed recent legislation (AB 2246) that requires districts to adopt a student suicide prevention policy before the 2017-2018 school year and provided additional language to the BP/AR to reflect local actions.

In support of the efforts to reduce youth suicide, and to help Districts prevent and respond to youth suicide, the San Mateo County Office of Education (SMCOE) and San Mateo County Health System created the San Mateo County Schools Suicide Prevention Toolkit, which will be available in its final form prior to the end of May, if not sooner. (See Draft attached to this Board item) The toolkit was developed through an extensive collaborative process involving community stakeholders, school mental health professionals, and suicide prevention experts including staff from County Behavioral Health and Recovery Services (BHRS). It outlines guidelines for identifying, intervening, and responding to suicidal and selfinjurious students. It also offers best practices to school site crisis teams to be used in the aftermath of a student death by suicide. Board: The Board was thankful that this topic is being covered as a proactive step.

- Individuals may address topics <u>not</u> on the agenda during the Communications Section (People Wishing to Address the Board) at the beginning of the meeting. However, the Board <u>cannot</u> comment on items not on the agenda.
- The Board, at their discretion, may limit the total time allotted for public comment during each agenda item.
- Individuals must be recognized by the Board President and step to the podium to speak.
- Speakers should introduce themselves and speak into the microphone. (The microphone is for the television and does not amplify sound.)
- Speakers are limited to a maximum of 3 minutes, which may be reduced at the discretion of the Board.
