5. <u>PRE-QUALIFICATION</u>. This contract is subject to prequalification. Prospective general contract bidders and all electrical, mechanical, and plumbing subcontractors are required to be prequalified. For further information regarding prequalification refer to Document 00 11 11 - Instructions to Bidders, item 3.

Because of the amount of the project scope that must be completed during the school's summer break across six sites at the same time, a qualified bidder must demonstrate the capability, resources, and strategies of completing the projects on time. Section 00 21 66 - Project Specific Qualifications, must be completed.

- 5. <u>RFI AND ADDENDA DURING BIDDING</u>. RFI shall be sent via emailed to Sisi Meng. <u>smeng@pacificasd.org</u>. RFI responses and addenda will be distributed electronically as PDF files via email or online download to all bidders who attended the prebid walk.
- 6. <u>BID BOND</u>. Bid Bond in the amount of **2%** of the total bid amount is required for the project. refer to Document 00 11 11 Instructions to Bidders, item 4 for details.
- 7. <u>PAYMENT BOND</u>. The successful bidder will be required to furnish a Payment Bond for one hundred percent (100%) of the Contract Sum, and a Faithful Performance Bond in the same amount. The bonds will be required prior to the execution of the contract. refer to Document 00 11 11 Instructions to Bidders, item 13 for details.
- <u>DVBE PARTICIPATION</u>. Attention is directed to the requirements of the Instructions to Bidders regarding goals for Disabled Veteran Business Enterprise (DVBE) participation on this project. This project has a goal of 3 percent Disabled Veteran Business Enterprise (DVBE) participation. Contractors are encouraged to ensure the maximum possible DVBE participation towards this goal.
- 9. <u>DIR</u>. Prospective general contract bidders and all subcontractors are required to be registered with the Department of Industrial Relations, in accordance with the provisions of Section 1725.5 of the California Labor Code.

The District has obtained from the director of the Department of Industrial Relations the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work in the locality in which the work is to be performed for each craft, classifications or type of work needed to execute the contract. Holiday rates shall be paid as specified in the collective bargaining agreement applicable to each particular craft, classification or type of work employed on the project.

Copies of schedules of rates so determined are on file at the District's office and are available to any interested party upon request. Copies of these determinations are also available online at http://www.dir.ca.gov/dlsr/pwd/. In accordance with Section 1773.2 of the California Labor Code, the Contractor shall post a copy of the determination of prevailing rate of wages at each job site. The Contractor and any subcontractor(s) shall pay not less than the specified prevailing wages to all workers employed by them in the execution of the contract.

- 10. <u>SECURITIE</u>S. In accordance with provisions of Public Contract Code Section 22300, substitution of eligible and equivalent securities for any monies withheld to ensure performance under this contract will be permitted at the request and expense of the contractor.
- 11. <u>LICENSE</u>. Each bidder shall possess at the time of bid a Class B Contractor's license, pursuant to Public Contract Code Section 3300 and Business and Professions Code Section 7028.15. The successful bidder must maintain the license throughout the duration of this contract.
- 12. <u>BID</u>. No bidder may withdraw his bid/proposal for a period of sixty (60) days after the date set for the opening bids. The District reserves the right to reject any and all bid/proposals and to waive any informalities or irregularities in any bid.
